No. 1/296/06-HSC: ~~A365~~ In pursuance of the letters bearing No. UHE-1/39/2026-THE-DHTE dated 29<sup>th</sup> April, 2026 of the Secretariat: Higher & Technical Education Department, Government of Manipur and No. 7-3/2012(AMPC) dated 9<sup>th</sup> April, 2026 from the Secretary/University Grants Commission (Ministry of Education, Govt. of India), it is hereby notified for information of all the Principals of the Higher Secondary Schools & Colleges under the Council that the following preventive measures should be taken to avoid admission of students in the fake Universities:

1. Inform and counsel students of classes X and XII, along with their parents/guardians, about the risks associated with self-styled universities/educational Institutions.
2. Advise students to verify the recognition status of Higher Educational Institutions (HEIs) from the official UGC website: [www.ugc.gov.in](http://www.ugc.gov.in) by visiting the "HEIs" tab in the main menu of the UGC website.
3. Display the UGC Public Notice dated 18<sup>th</sup> March, 2025 (**copy enclosed**) prominently on school notice boards and disseminate it through school websites, circulars, and parent-teacher meetings.

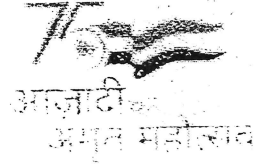

However, it has come to the notice of UGC that a number of institutions are offering degrees in contrary to the provision of the UGC Act. Degrees awarded by such universities/institutions shall neither be recognized nor valid for higher education and employment purposes.

Hence, all concerned are requested to check the UGC website: [www.ugc.ac.in](http://www.ugc.ac.in) for information about recognized universities/institutions as well as fake institutions before taking admission in any institution for higher education. Further, if any university/institution is offering academic programmes in contravention of the UGC Act, the same may also be brought to the notice of UGC via email to [ugcampc@gmail.com](mailto:ugcampc@gmail.com) so that appropriate action can be taken against such institutions.
