The candidates should fulfil the following criteria for applying the same:


**CRITERIA FOR FRESHER CANDIDATE:**

- (c) The candidate should not avail of any other scholarship.
- (d) The candidates should have his/her Aadhaar Number.

**CRITERIA FOR RENEWAL SCHOLAR:**

- (a) The Scholar should secure 50% or more marks or equivalent grade point average in aggregate and maintenance of attendance of at least 75%.
