## CIRCULATION OF FAKE NOTIFCATION IN SOCIAL MEDIA FOR CANCELLATION OF CLASS XI & XII EXAMINATIONS, 2021

It is found that a Notification dated 09-05-2021 purported to be issued by the Council of Higher Secondary Education, Manipur regarding cancellation of Class XI and XII Examinations, 2021 is being circulated through internet and social media.

It is clarified for information to all concerned and for the general public that the said Notification bearing No. 2/45/98-HSC(Vol IV) dated the 9<sup>th</sup> May, 2021 is a fake and fabricated document and the same has not been issued by the Council of Higher Secondary Education, Manipur.

The matter has been reported to the concerned police authorities for registration of FIR and necessary investigation.

It is further informed for all concerned that the Class XI and XII Examinations, 2021 are being postponed for the time being in view of the COVID-19 pandemic situation and any decision for cancellation of the examinations or otherwise are yet to be taken.

The media is requested for conveying the aforesaid information to the general public at large so that the anxieties of the students and parents involved may be eased during this unfortunate pandemic situation.

The Council further condemns such irresponsible actions affecting the lives of all students and parents involved including their mental health and wellbeing during this horrible COVID-19 situation.

It is further advised to all concerned that any official notification or information by the Council shall be uploaded in the official website - <u>www.cohsem.nic.in</u> and also circulated in the local daily newspapers and any unreliable information through unofficial channels or social média be treated with caution.
